

Terms and Conditions

Resisting Inaction, Resilience in Action Initiative Forum 2026

Event Dates

3rd - 7th April 2026

Requirements

You need to be at least 18 years old at the time of the event. If you are under 18 you must have a signed document by a parent giving you permission to attend and taking responsibility for the terms and conditions stated in this form.

Ticket prices & Finances

The Cost for attending the entire forum is SEK 1,950 (early bird), SEK 2,200 (regular).

These Costs cover:

- The Program, Courses, Course Materials, Evening Activities
- Meals (Breakfast, Lunch and Dinner, and two fikas)
- Accommodation (in shared dormitory style in a school gym)

The cost of a day ticket is SEK 600.

This cost covers:

- Courses, Course Materials, and Evening Activities for one day starting after breakfast from 9:00am until the end of the evening program at 22:00.
- Meals (Lunch & Dinner) are not included in this ticket. It is also not possible to purchase it from the forum on the day. Please bring your own food or purchase it from the Kulturhuset cafe on campus.

Meals

Meals are freshly prepared, using organic, biodynamic, and local produce and ingredients. There will be no refund given for meals skipped or missed.

Accommodation

The ticket price includes the use of a shared dormitory style accommodation in a school gym next to the conference venue. Further facilities like kitchens and bathrooms are shared with other participants. By agreeing to these terms and conditions you agree to keep the facilities clean and take responsibility for any damage caused by your misuse of the facilities.

Social conduct

YIP and the organizing team does not support or condone physical violence in any form. Participants may not promote violence against or directly attack or threaten other people.

YIP encourages clear, concise, truthful, respectful and responsible communication. Participants are encouraged to express themselves with clarity, compassion, self-responsibility, respect, empathy, transparency and the common good in mind.

Termination

Generally speaking, if a participant's behavior interferes with the orderly and efficient operation of the event and campus life, measures may be taken at the discretion of YIP and the organizing team, up to and including immediate termination from the Forum.

Participation in the Forum is "at-will." Accordingly, YIP and the organizing team may terminate the participation of an individual from the event and facilities at any time, with or without notice or prior procedure.

The following actions will result in immediate termination of participation in the event; theft of property; possession, manufacturing, sale, distribution, use or being under the influence of illegal drugs during the program; abuse of or attendance under the influence of alcohol; possession of a weapon; physical fights.

Educational/academic Freedom

Initiative Forum seeks intellectual variety among its contributors with respect to academic discipline and creative art, political and social thought, and philosophical or religious perspective. Maintaining a community environment of genuine educational freedom and respect for ideas and persons is essential to the purposes of the program and community.

Educational/academic freedom applies to both research and teaching. Freedom in research is fundamental to the advancement of truth. Educational/academic freedom is fundamental for protecting the rights of the contributor in teaching and of the participant to freedom in learning. These freedoms include that;

- Contributors are entitled to freedom of speech in the classroom and community. Education at YIP is based in large part on dialog and discussions that may or may not remain within the confines of the classroom. The type of discussion and dialog that explore the programs ultimate purposes of societal entrepreneurship and service to humanity cannot be subjected to

disciplinary or subject-centered restraint for fear of controversy or offense. Controversy, and even offense, is sometimes at the heart of both free academic inquiry and education. However, contributors should make every effort to be civil and respectful of others' views at all times.

• Contributors and organizers are citizens, members of a learned profession, and/or staff members of an educational institution. When they speak or write as citizens, they should be free from institutional censorship or discipline, but their special position in the community imposes special obligations. As educational staff members, they should remember that the public may judge their profession and their institution by their utterances. Contributors and organizers are entitled to participate as citizens in public forums without fear of discipline or restraint, so long as it is clear that they are not speaking for the YIP.

Passport/ID

Participation is conditional on bringing a passport or ID-card that is valid in Sweden for at least the entire duration of the event.

Event cancellation Policy

YIP and the organizing team reserves the right to withdraw the Forum if the number of participants is not sufficient, or if the financial resources needed for running the event are not sufficiently secured at any point prior to the beginning of the Forum. Fees will be refunded in full if YIP and the organizing team cancels the Forum.

Refund

Requests to withdraw from the event and obtain a full refund can be made up to one month before the event starts. After this time and if you leave the Forum during the event it is at the discretion of YIP and the organizing team whether you will receive a refund. Exceptions can be made due to medical reasons, conditional on a medical report.

This must usually be specified when making the payment. YIP cannot accept any payment as being in full unless the correct amount in SEK (Swedish Kronor) is credited to its account. Copyright and Ownership

YIP and the organizing team accepts and emphasizes the Participants' customary right to ownership of rights to commercial use of artistic or literary works (meaning music, photos/ paintings/drawings, presentations, research papers, and the like) produced as a part of or related to program activities during the Forum, with the following exceptions:

• YIP and the organizing team may use the above-mentioned artistic or literary works (if made available to YIP in physical or digital form) for the purpose of promoting YIP free of charge. Participants must request in writing if specific works should be excluded from this use. Excluded from this use are also any documents which (if published) would be a breach of Swedish law or infringing upon the privacy, integrity or wellbeing of the Participant or others.

• For works produced by Participants specifically for YIP's use upon YIP's request (such as Lecture recordings, promotional videos and published products thereof), YIP retains the ownership and right to commercial use.

What is expected of you as a part of the Forum Community?

The success of the forum relies on the mutual commitment of everyone involved. The organizing team commits to high quality content for the program, staying flexible to adapting the program according to actual and current issues and societal trends, creating a personalized positive learning experience, and securing effective use of financial resources.

As a participant your commitment includes attending the program, paying your Forum ticket and acting responsibly in any of the roles you may take on during the Forum. Both the organizers and the participants are asked to contribute time and work to help the functioning of daily life at the Forum.

Communication

Your acceptance of these terms includes your agreement to the terms and conditions from Brevo. Brevo is the service provider through which YIP communicates its automated emails and newsletters.

Visas

Participants who are not citizens of Sweden/EU/EEA/Nordic countries might need a Visa to attend the Forum.

The agreement to take part in the Forum is conditional upon the Participant obtaining the appropriate Visa or Permit to enable him/her/them to be in Sweden. Admission to the Forum does not guarantee that the Participant will be issued with the appropriate visa or permit. The Participant is responsible for complying with all conditions relating to the visa or permit.

Healthcare

In the case of behavior and events resulting from the failure to engage, maintain or sustain the needed professional and/or medical support ensuring the participants ability to carry out normal day-to-day activities, attend events, remain respectful in relationship, and stay in any shared residency during the forum, or that puts the organisers in danger of over-stretching their professional mandate, YIP and the organizing team reserves the right to terminate participation in the Forum.

Health- and Travel-Insurance

Participants are required to have appropriate health- and travel-insurance for the period of their stay at the Forum.

Participation is conditional upon the Participant obtaining and maintaining the appropriate health and travel insurance for the time staying at the Forum. Admission to the Forum does not guarantee that the Participant will be covered for any costs related to health or travel. The Participant is responsible for complying with all conditions relating to the health and travel insurance.
